Payment Procedures

Payment is due at time of registration. This is required of all Becker students no matter when their materials are shipped. If paying by check, FedEx or Registered Mail is best. You must send check at time of registration to: Becker Professional Education 200 Colonial Homes Drive Ste. 204 Atlanta, GA 30309. If paying by credit card, the card will be processed at time of registration. We will inform you of any difficulties we have in processing your card. Please call your credit card company in advance in case you need to raise your limit, or offset any security features your card may have. Tax is included at 8% for your convenience. Tax is only charged on Flashcards and Final Review.

Intensive Discount Policy

There are no firm discounts for the Becker Intensive program. One discount you can receive is if you sign up for all four parts of the review. You will receive \$700 off for registering for all four sections. If you drop any of the parts, after the cancellation policy, the \$700 discount will not apply. Another discount available is Tuition Free Continuing Help (TFCH) available for qualified previous Becker students. When you register for Intensive, to qualify for a discount you need to fax or scan your receipt of what you previously paid with your registration. If you do not already have these documents you may obtain them by calling 1-800-868-3900 or 1-630-472-2213 for outside the U.S. If you took the Becker INTENSIVE course before, but did not earn TFCH, then you will receive half off the Intensive course. If you took a REGULAR Becker course (NOT Intensive in Atlanta), then you will receive half off the price you paid, applied to the price of the Intensive course with proof of registration. For example, if you originally paid \$1000.00 for the Regular Becker course, then you will receive \$500.00 (1/2) off the Intensive course.

Cancellations/Refunds Policy

For Individual Part Candidates: A full tuition refund (less any discounts and fees) will be issued prior to the second class with refund of materials. For Intensive each day holds two classes. Thereafter, there will be no refund.

For 4-Part Candidates: A full tuition refund (less any discounts and fees) will be issued prior to the second class with refund of materials. Payment Scenarios

Students who will be paying with Company credit cards must bring the actual credit card for hotel check-in, or have a front and back copy of the card made and faxed to the hotel with a signed authorization form. Included in the fax please indicate whether the credit card will cover all hotel charges or just room and tax.

Students who will be paying with cash or travelers checks for their hotel accommodations are required to put an extra deposit of \$50.00 for incidental charges. This includes phone calls, movie rentals, and laundry detergent, as well as grocery shopping service if used.
