**RULES FOR FOUR-PART CANDIDATES** (Applicable to Live and Online CPA Exam Review formats)

- Upon initial registration a candidate must enroll in all four CPA Exam Review parts and complete all four parts in a 12 month period.
- Within the 12 month period from initial registration, a candidate may change the course format, delivery method or sequence of their CPA Exam Review parts. No charge will apply for the first change; however, an administrative fee will apply to all subsequent changes.
- A candidate enrolled in all four parts, starting one or more of the parts past the 12-month period, will be required to re-enroll as a former candidate and will be charged 50% of the current tuition plus applicable fees for those parts.

**RULES FOR INDIVIDUAL-PART CANDIDATES**

- At any time within the 12-month period a candidate enrolled in individual parts may change the course sequence or delivery method prior to the 2nd lecture of that part (Financial, Regulation, Auditing, or Business). New sequence or format must begin with original 12-month period.
- A candidate enrolled in individual parts starting one or more of the parts past the 12-month period, will be required to re-enroll as a former candidate and will be charged 50% of the current tuition plus applicable fees for those parts.

**IN CLASS CANCELLATIONS/REFUNDS:****Applicable in all states except those noted below:**

**For Individual Part Candidates:** A full tuition refund (minus all applicable savings and fees) will be issued to students who withdraw prior to the second class day. Thereafter no refund will be issued.

**For Final Review Individual Part Candidates:** A full tuition refund (minus all applicable savings and fees) will be issued to students who withdraw two days before the start of each part. Thereafter, no refund will be issued.

**For 4-Part Candidates:** A full tuition refund (minus all applicable savings and fees) will be issued to students who withdraw prior to the second class day. From the day of the second class and prior to the day of the fifth class, candidates will be charged full tuition for the part taken (plus fees) and refunded the balance. There will be no refund after the fifth class day.

**For Final Review 4-Part Candidates:** A full tuition refund (minus all applicable savings and fees) will be issued to students who withdraw from all four parts prior to two days from the start of the first part scheduled. Thereafter, no refund will be issued for any of the four parts.

**Applicable in Alabama, Arkansas, District of Columbia, Kansas, Kentucky, Louisiana, Nebraska, Nevada, New Hampshire, New Mexico, Oklahoma, Washington, West Virginia, Wisconsin:**

If cancellation occurs within 3 business days of registration, all monies paid by the student (including registration fee) will be refunded even if classes have already started.

Registration Fee cannot exceed \$50 in D.C. and West Virginia or 5% of tuition in New Mexico.

**For Individual Part Candidates:** A full tuition refund (minus all applicable savings and fees) will be issued to students who withdraw prior to the second class; thereafter, candidates are entitled to a prorated refund (minus all applicable savings and fees) for the unused portion through 60% of the part taken (75% in Arkansas and DC).

**For 4-Part Candidates:** A full tuition refund (minus all applicable savings and fees) will be issued to students who withdraw prior to the second class; thereafter, candidates are entitled to a prorated refund (minus all applicable savings and fees) for the unused portion through 60% of the entire course (75% in Arkansas and DC).

Refunds are contingent upon the return of all textbooks and software within 10 days of notification of withdrawal. Candidates must also contact Becker for a Return Materials Authorization number prior to shipping returns. Candidates should ship materials by certified mail or an alternative traceable method. The registration fee and charges for the Becker Promise materials and flashcards are non-refundable. The cost to return materials is the responsibility of the candidate. A candidate may change the sequence or delivery method at any time within the original 12-month period. A \$195 administrative change fee will be charged beginning with the 2nd change and will apply to all subsequent changes.
